This information is important. Please read it carefully. Submission of an online or printed Booking Form along with payment of required trip deposit indicates you have read and expressly agree to these Terms and Conditions. If there is something that you do not understand please ask us about it!

**Reservations and Payments** - A non-refundable deposit of \$400 is required at the time of booking. Written confirmation will be provided upon receipt of deposit. Balance of payment will be due 60 days before departure. Tour price is based on exchange rates in effect as of April 22, 2020 and are subject to adjustment on final invoice.

**Number of Guests:** A maximum of 18 guests per tour can be accommodated. A minimum of 16 guests are required to operate the tour at quoted price. Purchase of non-refundable services outside of tour itinerary (such as airline tickets) before minimum number of guests have registered is at the sole risk and expense of the guest.

**Cancellations** - All cancellations must be made in writing. As noted, final payment is due 60 days prior to departure and is non-refundable. Accordingly we strongly recommended that you purchase appropriate cancellation insurance. **Hotels** - Hotels are shown on your itinerary. Sterling Tours reserves the right to change any hotel through any circumstance---the substitute will be of equal or higher quality.
